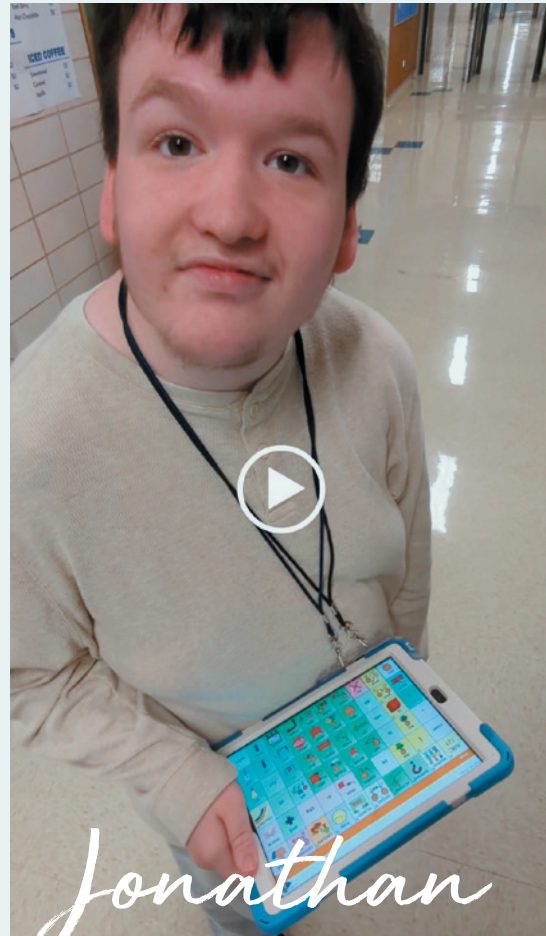
Dear friends,

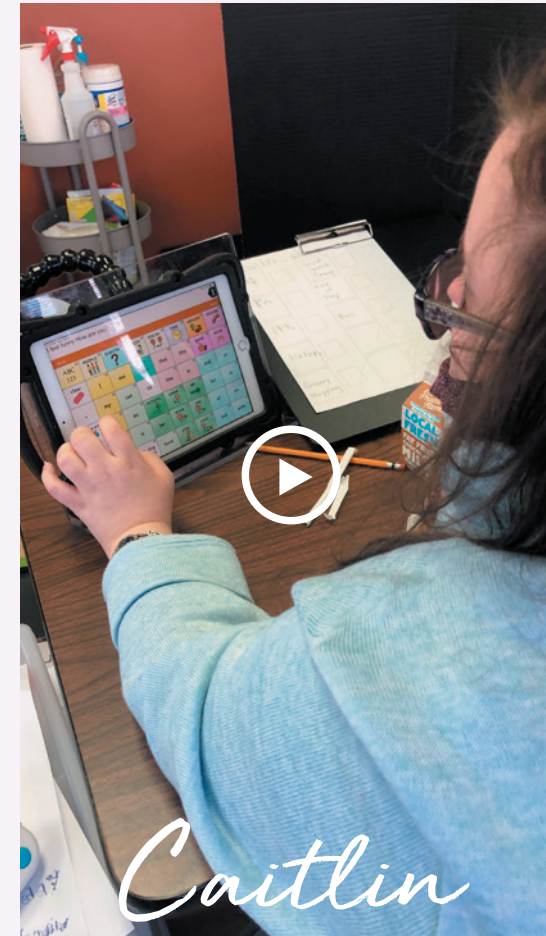

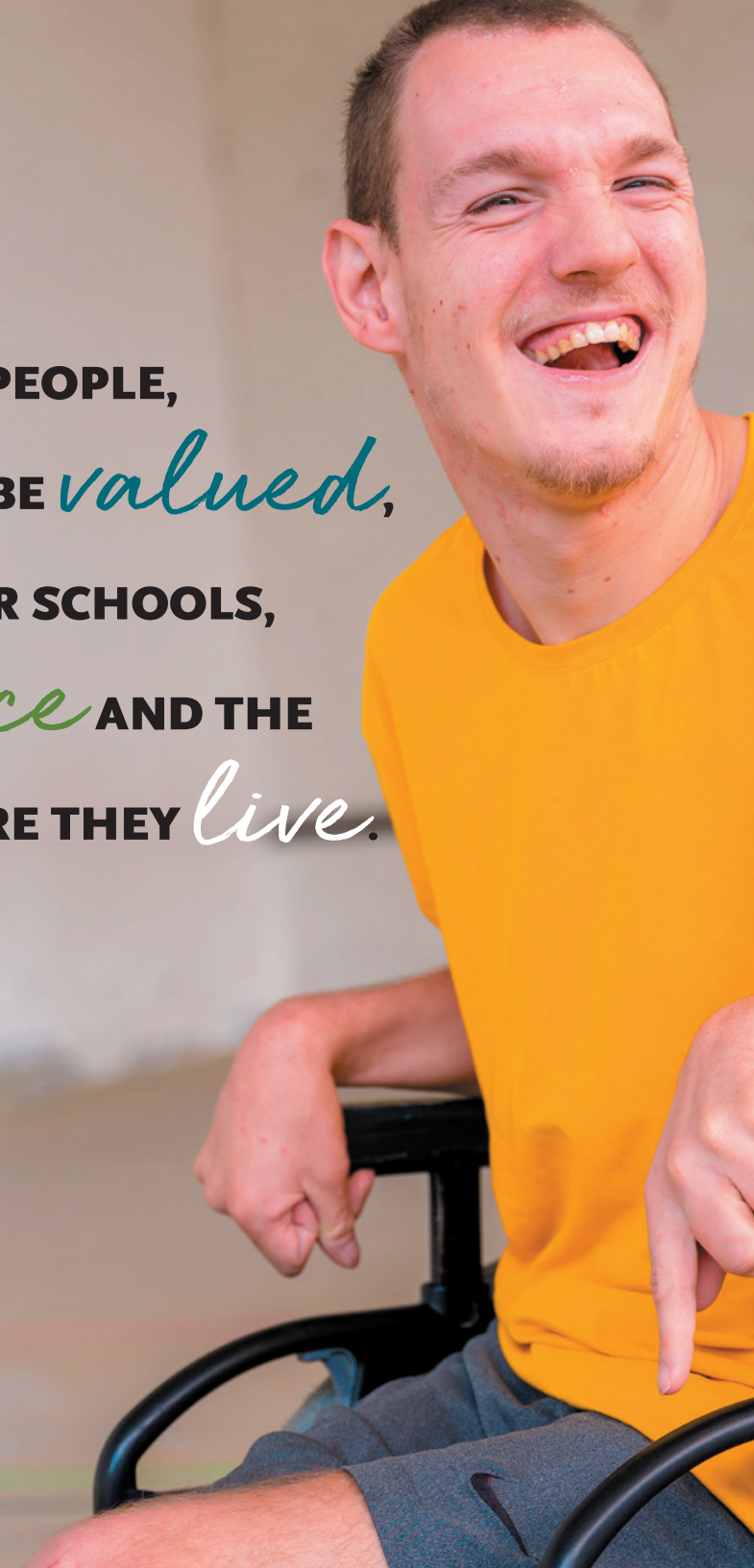
